### FACTORS INFLUENCING ADOPTION OF IMPROVED TOMATO SEED VARIETIES AMONG SMALL-SCALE TOMATO FARMERS IN SOUTH WEST ZONE OF NIGERIA \*Ogundeji, O. R. and Ogunwande, I. O.

### ABSTRACT

The study examine the factors influencing adoption of improve tomato varieties among small-scale farmers in Southwest Nigeria. Data were collected via structured questionnaires and analyzed using descriptive statistics, probit regression, and Likert scales. The findings revealed that 41.4% of the farmers were in their productive years with an average age of 45 years, predominantly male (70.0%), married (81.9%), with small households averaging five members. However, 87.5% had formal education and average of eight years of tomato farming experience. The farmers cultivate an average of 0.63 hectares, indicating small-scale operations. Furthermore, 85.6% of the farmers were not part of cooperatives. The result also shows that 80.0% and 65.0% of the farmers lack access to credit and extension services in the study area. Logic regression model reveal 68.39% probability of adoption of improve tomato seed varieties among farmers. Key factors significantly influencing adoption include age, gender, farming experience, education, access to extension services, market distance, input supply, and specific training. Major challenges include high input cost (73.8%), pests and diseases (55.6%), lack of credit (61.9%), marketing issues (28.8%) and unfavorable weather (18.1%). Therefore, recommendations from the study include strengthening extension services, raising awareness of cooperative membership benefits, and addressing farmers' priorities and needs.

### **INTRODUCTION**

The agricultural industry is crucial for developing nations, providing employment and contributing significantly to foreign exchange and national income (Adinan, 2021). In Nigeria, agriculture is vital, linking rural and non-farm economies by generating employment and contributing to GDP and economic growth (Akande, 2012; Oyinbo and Rekwot, 2014). Tomatoes are a significant crop in Nigeria and Sub-Saharan Africa, primarily grown by small-scale farmers, with high consumption across the country (Tafida and Ayuba, 2020; Babalola *et al.*, 2010). In 2019 and 2020, Nigeria's tomato production was 3,798,939 tons and 3,693,722 tons, respectively (FAO, 2020). Despite this, output fails to meet demand due to resource constraints among smallholder farmers (Alabi *et al.*, 2023). Adopting high-quality seeds and modern agricultural inputs is crucial for improving productivity (Adinan, 2021). Increasing agricultural output requires diversifying production methods beyond traditional practices (Azumah *et al.*, 2019).

Adoption of new technologies depends on farmers' perceptions and involves a complex decision-making process (Rogers, 2003; Michelsen *et al.*, 2013). Many small-scale farmers lack access to essential knowledge and technology, hindering productivity (Syngenta, 2020). Adoption remains low among smallholder farmers in Southwest Nigeria (Awotide *et al.*, 2016). Low tomato yields, averaging 20-40 tons per hectare annually, are due to outdated seed varieties, pests, and poor soil fertility (Michael & Kolawole, 2020; Ugonna *et al.*, 2015). Improving tomato productivity requires institutional changes and widespread adoption of enhanced technologies

(Donkoh, 2016). However, benefits from new technologies will only be realized if inefficiencies in agricultural input use are addressed (Ogunniyi and Oladejo, 2011). Hence, there is a need for further investigation into the factors affecting farmers' decision to adopt improved seed varieties among small-scale farmers in Southwest, Nigeria. The objectives of the study are to (i) describe the socioeconomic characteristics of the respondents; (ii) determine the factors affect to adoption of improved seed varieties and (iii) identify the constraints mitigating against tomato production among respondents in the study area.

## MATERIALS AND METHODS

### The Study Area

The study was carried out in Southwest, Nigeria. The region lies between latitudes  $4^0$  and  $9^0$ N and longitudes  $30^0$  and  $7^0$ E with a total land area of 77,818km<sup>2</sup> and a total population of 28,767,752 (Oni and Odekunle 2019). The region's temperature ranges between  $21^0$ C and  $34^0$ C while the annual rainfall ranges between 150mm and 3000mm and the temperature ranged between  $15^0$ C and  $30^0$ C. The region enjoys tropical climate with two distinct seasons, the rainy season (April-October)and the dry season (November - March). The vegetation in Southwest Nigeria is made up of freshwater swamp and mangrove forest at the belt, the lowland forest stretches inland to Ogun and part of Ondo State while the secondary forest is towards the northern boundary where Derived and Southern Savannah exists (Ojo and Baiyegunhi, 2008). The region is comprised of six states: Ekiti, Lagos, Ogun, Ondo, Osun and Oyo.

### **Sampling Techniques**

A multistage sampling procedure was used for this study. The first stage involved a purposive selection of two states (Oyo State and Ondo State) out of the six states in Southwest region, Nigeria, due to the high tomato production. The second stage involved a random selection of four (4) Local Governments from each State respectively. In the third stage, a snowball sampling technique was used in selecting ten (10) adopters and ten (10) non-adopters of improved tomato seed varieties, making a total of twenty (20) tomato farmers from each Local Government of Oyo and Ondo State respectively. A total sample size of one hundred and sixty (160) respondents was used for this study comprising of eighty (80) adopters and eighty (80) non-adopters of improved tomato seeds varieties.

# Analytical Techniques

# **Descriptive Statistics**

Descriptive Statistics was used in analyzing and describing the socio-economic characteristics of the respondents as stated specifically in objective one (i), determine the factors affecting decision to adopt improved seed varieties as stated in objective two (ii), and to identify the constraints facing tomato producers as specifically stated in objective three (iii). Descriptive statistics consist of frequency counts, percentages, mean among others.

### **Logic Regression Model**

Logic Regression Model was used to determine the factors affecting farmers' decision to adopt improved tomato seed varieties as stated specifically in objective two (ii). When the dependent variable has two outcomes, this model is applied. Suppose response variable *Y* is *binary*, it can have only two possible outcomes which could be denoted as 1 and 0, where 1 symbolizes farmers who adopted improved seed varieties (adopters) and 0 depicts farmers who did not adopt improved seed varieties (non-adopters). The logic regression model was specified as:

### **RESULTS AND DISCUSSION**

### **Socio-Economic Characteristics of Tomato Farmers**

The socio-economic characteristics are presented in Table 2. The data shows that 41.4% of respondents were aged between 41 and 50 years, with a mean age of 45, indicating they are middleaged and likely capable of the rigorous work required for tomato farming. This aligns with Adegboye *et al.* (2021), who found most tomato farmers were aged 41-60 years. Men comprised 70% of the farmers, reflecting the strenuous nature of the work and social norms regarding gender roles, consistent with Abimbola (2014). Most respondents (81.9%) were married, with an average

household size of five, suggesting that married individuals, seen as responsible, dominate agricultural production. This supports Adegboye *et al.* (2021) view that marriage brings responsibility to farmers. About 88% of respondents had formal education, enabling them to read and follow farming instructions, consistent with Ajagbe *et al.* (2014). Education is crucial for accessing and adopting innovations in tomato farming (Tafida and Ajuba, 2020). All respondents were small-scale farmers with less than 5 hectares of land and an average of 8 years of farming experience, indicating their extensive knowledge and profitability in farming. The majority (51.3%) relied on farming as their primary occupation, contradicting Adegboye *et al.* (2021), who found most had other primary occupations. Most farmers (85.6%) were not part of any cooperative society, 80% had no access to credit, and 65% were not visited by agricultural extension agents.

### **Factors Affecting Decision to Adopt Improved Tomato Seed Varieties**

Analysis in Table 3, based on the Logic regression model reveal 68.39% probability of adoption of improve tomato seed varieties among farmers. The factors that significantly influenced the adoption of improved tomato seeds includes years of education, access to extension services, and distance to market were significant at (p<0.01). Age, gender, farming experience, distance to input supply, and specific training on improved seed use were significant at (p<0.05), while tomato yield was significant at (p < 0.1%).

The result revealed that years of education of the household head positively impacted adoption, with each additional schooling year increasing the likelihood of adoption of improved tomato by 0.39%. This suggests that literate farmers are more inclined to adopt improved seeds, consistent with Ahmed (2015). Access to extension services negatively influenced adoption, decreasing the likelihood by 30.07% due to low access in the study area. Similarly, increased distance to market decreased adoption likelihood of adoption of improved tomato varieties production by 10.29%, indicating that proximity to market sites encourages adoption. Additionally, age had a negative effect, with older farmers being 20.14% less likely to adopt improved seeds, possibly due to higher risk aversion and a decreased interest in long term investment in the farm while, younger farmers are typically less risk averse and are more willing to try new technologies. This contrasts with Ojo and Ogunyemi (2014) who reported that age had a positive influence on adoption decision of improved cassava production technology in Ekiti State

Furthermore, gender was significant, with male-headed households more likely to adopt improved seeds, likely due to better access to training and information, aligning with the findings of Mangisoni et al. (2019). Farming experience positively influenced adoption, increasing the likelihood of adopting improved tomato varieties by 3.27% per additional year of experience, contrary to Alemayehu (2020). Increased distance to input supply sites decreased adoption likelihood of adopting improved tomato seeds by 11.91% as farmers with improved seed supply

sites in their immediate environment were more likely to adopt improved seeds than those living in areas far from the supply site. Finally, tomato yield was also found to be positively significant in determining the adoption decision at 10% significance level. This implies that an increase in the yield of improved tomato seeds will increase the likelihood or probability of adoption by farmers, indicating that the superior yield of improved seeds is a critical factor for adoption, similar to the findings of Dugue *et al.* (2015).

### **Constraint of Tomato Production**

Constraints are any issues that can reduce a tomato farmer's output. The result shows that 73.8% of farmers reported high cost of inputs (improved seeds, fertilizers, and herbicides). This aligns with Alabi *et al.*, (2023), who found that high input costs hinder productivity. The second major issue, cited by 61.9% of farmers, is pest and disease problems due to insufficient access to necessary chemicals. Additionally, 55.6% of farmers reported that lack of credit facilities is a significant constraint, as it limits their ability to expand production due to high interest rates, short repayment periods, and collateral requirements.

### **CONCLUSION AND RECOMMENDATIONS**

In conclusion, the adoption of improved seed varieties among small-scale farmers is essential for enhancing productivity and sustainability. Transitioning from traditional farming methods to improved seed varieties can significantly boost yields, improve resilience to pests and diseases, and increase overall farm profitability. Encouraging this shift through education, access to credit facilities, and support from agricultural extension services is crucial for achieving longterm agricultural development and food security. Therefore, recommendations from the study include strengthening extension services, raising awareness of cooperative membership benefits, and addressing farmers' priorities and needs.
