# ANALYSIS OF AWARENESS AND ACCESSIBILITY OF INFORMATION AND COMMUNICATION TECHNOLOGIES (ICTs) AMONG CROP FARMERS IN KANO STATE, NIGERIA

#### **ABSTRACT**

The study examined the awareness and accessibility of information and communication technologies (ICTs) among crop farmers in Kano State, Nigeria. A multi-stage sampling procedure was used to select (162) respondents. Data were collected using a well-structured questionnaire and analyzed with descriptive and inferential statistics. The results showed that (56.2%) of respondents were rice farmers, while (15.4%), (14.8%), and (13.6%) were millet, sorghum, and maize farmers, respectively. The findings revealed that (35.8%) of respondents were aged (41–50) years, with the majority (90.7%) being male and married (92.6%), and having an average household size of 11 members. Additionally, (30.3%) had completed secondary education, and 63.6% belonged to cooperative societies, with an average income of (\$\frac{1}{872},143.84\). Regarding awareness, mobile phones (100%) and radios (96.3%) were the most recognized ICT components, indicating widespread awareness among crop farmers. In terms of accessibility, mobile phones (96.3%), radios (92.6%), and televisions (67.9%) were highly accessible. Furthermore, in utilization, farmers predominantly used mobile phones (93.8%), radios (88.3%), and televisions (61.7%). Logistic regression analysis indicated that household size, education level, farming experience, and cooperative membership significantly influenced ICT awareness and accessibility at p $\leq$ 0.05, p $\leq$ 0.01, p $\leq$ 0.05, and p $\leq$ 0.05 levels, respectively. The major constraint identified was inadequate skills in using ICTs (98.8%). Despite this limitation, most respondents reported utilizing ICT tools and acknowledged their potential to improve access to agricultural information. The study concludes that mobile phones, radios, and televisions are the most recognized, accessible, and utilized ICT components among crop farmers, with mobile phones leading in all three categories (100% awareness, 96.3% accessibility, 93.8% utilization). It recommends that farmers actively participate in cooperative societies to leverage shared resources, strengthen support networks, and advocate for policies promoting ICT acceptance.

#### **INRODUCTION**

Agriculture supports about 25–30% of the global population (FAO, 2020), yet its progress is often hindered by limited awareness, accessibility, and utilization of modern technologies among farmers. Information and Communication Technologies (ICTs) have emerged as powerful tools to bridge this gap, enhancing access to timely information on farm practices, markets, and weather forecasts (Aker, 2017; Jensen, 2020). In Nigeria, and particularly Kano State, agriculture remains central to livelihoods, but inadequate ICT adoption constrains productivity. Many studies highlight that, ICT-based agricultural extension can significantly improve efficiency and decision-making (Adera *et al.*, 2016; IFAD, 2019). However, farmers' awareness, accessibility, and utilization of ICTs remain inconsistent due to infrastructural, socio-economic, and cultural barriers. Despite government recognition of extension's importance, ICT adoption among Kano crop farmers is low. Farmers face inadequate awareness, limited accessibility, skepticism about ICT effectiveness, and demographic

disparities in adoption. Traditional reliance on face-to-face extension is further weakened by declining extension worker numbers. These challenges restrict farmers' ability to access vital agricultural information, limiting productivity and sustainability (Aker, 2017; Oyekele *et al.*, 2018). The objectives are to:

- i. Describe farmers' socio-economic characteristics;
- ii. Assess awareness, accessibility, and utilization of ICTs;
- iii. Identify factors influencing ICT awareness and utilization.
- iv. Determine factors the utilization of ICT and;
- v. Identify constraints to ICT utilization.

#### **METHODOLOGY**

#### **Study Area**

The study was conducted in Kano State, Nigeria, which was created in 1967. The state lies between latitudes 10°33′ N and 12°37′ N and longitudes 7°43′ E and 9°35′ E. According 2006 census the total population of Kano state was 9401,288 With a projected population of approximately 16253,549 in 2024 (KNSG Subdivision,2024), it falls within the tropical wet and dry climatic zone of northwestern Nigeria. The state comprised of 44 Local Government Areas (LGAs) and shares boundaries with Jigawa State to the northeast, Kaduna State to the southwest, Bauchi State to the southeast, and Katsina State to the northwest. The climate is characterized by a rainy season from April to October, followed by the Harmattan season (November to February). Mean annual rainfall varies across the state: about 1,000 mm in the south, 800 mm around Kano urban, and 600 mm in the northeast (KNARDA 2019). Agriculture is the backbone of the state's economy, involving both crop and livestock production. Kano is renowned for producing millet, sorghum, maize, rice, wheat, groundnuts, and vegetables. Livestock production, particularly cattle, goats, and sheep, is widespread, with the Kano cattle market being one of the largest in West Africa (KNARDA, 2019).

#### **Sampling Technique and Sample Size**

A multi-stage sampling technique was adopted: Stage 1: Six LGAs were purposively selected based on high concentrations of crop farming (rice, millet, sorghum, maize). Stage 2: From each LGA, three wards were randomly selected using a ballot method, giving 18 wards. Stage 3: One village was randomly selected from each ward, totaling 18 villages. Stage 4: A 10% sample of the farming population was drawn from each village, yielding a total of 162 respondents out of a sampling frame of 1,620.

#### **Data Collection and Analysis**

Primary data were collected using structured questionnaires and interview schedules, administered with the help of trained enumerators fluent in English and Hausa. The descriptive Statistics such as frequencies, percentages, means, and ranges were used to describe farmers' socioeconomic characteristics, ICT awareness, and constraints.

Percentage: This was employed to establish the population of the respondents to a particular response. Percentage is written mathematically as

**Logistic Regression Analysis:** The logistic regression model, as used by Giorgio *et al.* (2023), can be implicitly expressed as:

 $X1 = Age (years), X2 = Gender (Male = 1, Female = 2), X3 = Education level (years), X3 = Farming experience (years) and X5 = Estimated on-farm income (<math>\aleph$ ).

Pearson correlation was employed to measure the relationship between socio-economic characteristics and ICT utilization. The coefficient () was computed as:

#### RESULTS AND DISCUSSION

#### **Socioeconomics Characteristics of the Respondents**

Table 2 presents the socio-economic characteristics of crop farmers in Kano State. The results revealed that 35.8% of the respondents were within the age bracket of 41–50 years. This is consistent with the finding of Adebayo *et al.* (2017), who reported that the majority of crop farmers with access to ICTs in Nigeria were between 30-59 years old, aligning with the economically active age range with a mean farming experience of 23 years. This indicates that most farmers are in their economically active years, with substantial farming experience to potentially enhance technology adoption. The average household size was 11 members, reflecting the extended family system common in northern Nigeria. The results also showed a dominance of males (90.7%), while females accounted for only 9.3%. This imbalance is consistent with earlier findings that male farmers have greater access to productive resources and information compared to female counterparts (Ali *et al.*, 2016). Furthermore, 92.6% of the respondents were married, indicating farming as a family-oriented activity. In terms of education, 30.3% had completed secondary education, suggesting moderate literacy levels among respondents, which could enhance ICT adoption. Additionally, 63.6% were members of cooperative societies, providing opportunities for knowledge sharing and collective access to ICT resources.

#### Awareness, Accessibility and Utilization of ICTs

Findings revealed ICT Tools Awareness, Mobile phones (100%) and radio (96.3%) are the most recognized ICT components, indicating widespread awareness. This implies that, Mobile phones and radios are pivotal for information dissemination given their high awareness, accessibility, and utilization rates and expand agricultural extension programs using mobile applications, SMS alerts, and radio broadcasts to reach more farmers effectively. Accessibility, Mobile phones (96.3%), radios (92.6%), and television (67.9%) is highly accessible. furthermore, Utilization, Farmers predominantly utilize mobile phones (93.8%), radios (88.3%), and television (61.7%). This is consistent with findings by Adebayo *et al.* (2017), who reported the widespread use of mobile phones among Nigerian farmers for agricultural purposes. Furthermore, Low awareness is observed for media vans (22.8%), internet (24.7%), and pamphlets (16.0%). Low accessibility is reported for pamphlets (13.0%), media vans (6.2%), and computers (17.9%). This suggests that media vans are less common and less utilized for agricultural extension services in the study area. This is consistent with findings from Levi (2015), who noted limited use of media van units in rural farming communities

#### **Factors Influencing ICT Awareness and Accessibility**

The logistic regression model (Table 3) examined the determinants of ICT awareness among crop farmers. The -2 Log Likelihood of 88.680 (p = 0.001\*\*) indicated a moderately good model fit. The Cox and Snell R² value of 0.298 showed that 29.8% of the variance in ICT awareness was explained by the independent variables, while the Nagelkerke R² value of 0.502 suggested that 50.2% of the maximum possible variance was explained.

The results indicated that household size  $(.015^*, p < 0.05)$ , The negative coefficient (B = -.126) indicated that for every one-unit increase in household size, the likelihood of utilizing Information and communication technology for agricultural information decreases by 12.6% (exp(B). This is similar findings have been reported by Adekunle *et al.* (2017), who found that household size was significantly negatively related to the adoption of Information and communication technology in agricultural extension services in Nigeria. Education level (.011\*\*, p <0.01), this implies that for every one-unit increase in education level, the odds of using ICT in excessing agricultural information increase by 123.2%. This is consistent with findings by Adebayo *et al.*, (2017) and Adekunle *et al.*, (2017), who found that education level was a significant factor in information and communication technology adoption in agricultural extension services in Nigeria. Farming experience (.005\*, p

<0.05), The exponentiated coefficient  $\text{Exp}(\beta)$  is 1.146, suggesting that for each additional unit of farming experience, the odds of utilizing Information and communication technology in accessing agricultural information increase by a factor of 1.146, holding all other variables constant. This finding contrasts with studies by Mango *et al.* (2015) and Diiro (2013), which found that farming experience had a negative and significant impact on information and communication technology adoption and cooperative membership (.001\*, p <0.05) The exponentiated coefficient  $\text{Exp}(\beta)$  is 1.146, implies that for each additional unit of farming experience, the odds of utilizing Information and communication technology in accessing agricultural information increase by a factor of 1.146, holding all other variables constant. This finding contrasts with studies by Mango *et al.* (2015) and Diiro (2013), which found that farming experience had a negative and significant impact on information and communication technology adoption.

#### **Constraints to ICT Utilization**

The most critical constraint identified was inadequate skills in using ICTs (98.8%), followed by poor network connectivity, high costs of devices, and limited electricity supply. These challenges echo the findings of IFAD (2019), which highlighted infrastructural and literacy barriers as major impediments to rural ICT adoption. The results demonstrate that while crop farmers in Kano State are generally aware of ICTs, actual access and utilization remain constrained by socio-economic and infrastructural factors. Education, farming experience, and cooperative membership emerged as significant enablers, underscoring the need for capacity-building initiatives and collective action approaches. Similar to Aker (2017), the study confirms that ICT tools such as mobile phones and radios remain the most practical entry points for rural farmers. However, advanced ICT platforms require stronger policy support, training, and rural infrastructure development.

#### CONCLUSION AND RECOMMENDATION

The study concludes that ICTs have strong potential to improve agricultural extension services and farmers' income in Kano State; The study found that socioeconomic factors like age, marital status, education, farming experience, household size, and income significantly influence the awareness and accessibility of ICTs among crop farmers in Kano State, Nigeria, with radio and mobile phones being the most effective tools due to their availability despite unreliable electricity.

Based on the findings in the study area, the following recommendations are proffered:

• Stakeholders, should collaborate to improve education levels among crop farmers in Kano State, Nigeria, to enhance ICT adoption and unlock its socioeconomic benefits.

- Radio and mobile phones are effective ICT tools, and the government should develop more agricultural radio programs accessible via mobile phones while encouraging cooperative societies to improve access to information, resources, and policy advocacy.
- To address barriers like high internet costs, inadequate skills, and poor electricity supply, the government should subsidize costs, establish monitoring mechanisms, and NGOs should strengthen institutional linkages for effective extension service delivery.
