



## EFFECTS OF MUTATIONS OF MYOSTATIN (MSTN) GENE IN BREEDS OF SHEEP IN NIGERIA

## ABSTRACT

Growth Differentiation Factor 8 (GDF8), also known as myostatin, is a member of the Transforming Growth Factor  $\beta$  (TGF $\beta$ ) superfamily. It has been reported to act as a negative extracellular regulator and a significant negative regulator of skeletal muscle mass, muscle growth, and development. This research was carried out to identify the effects of molecular genetic variation of the myostatin (MSTN) gene in breeds of sheep in Nigeria, using, in silico tools. A total of eight myostatin (MSTN) nucleotide sequences were retrieved from NCBI (National Centre for Biotechnology Information) website (www.ncbi.nlm.nih.gov) it was aligned, translated, and compared using Clustal W from MEGA to find genetic distances and evolutionary relationships. BLAST tool was used to align and identify the mutations of the sequences considered. The variation in sequence length base pairs (bp) were 511 and 580 bp. Functional analysis of missense mutations using SIFT identified twenty-one (21) amino acids substitutions in the myostatin (MSTN) gene sequences. (18 were tolerant or beneficial while 3 were deleterious or harmful). There were 7 Essential to Essential substitutions, 5 Essential to Non-Essential substitutions, 4 Non-Essential to Non-Essential substitutions, 5 Non-Essential to Essential substitutions. The beneficial mutations were more prevalent than the harmful mutations. There should be Implementation of selective breeding strategies to propagate the beneficial mutations identified, enhancing muscle growth and meat yield in breeds of sheep in Nigeria.

### **INTRODUCTION**

Meat products from ruminants like sheep play vital role in the agricultural sector of most countries (Selvaggi *et al.*, 2015). The Food and Agriculture Organization (FAO, 2023) reported that the economic importance of sheep in developing nations cannot be overemphasized. Sheep, with their small body size, high productive capacity, and rapid growth rates, are ideally suited to production by resource-poor smallholders. FAO (2023) further highlighted that in sub-Saharan Africa, sheep provide almost 30 % of the meat consumed and around 16 % of the milk produced. Sheep contribute about 50 % of the total domestically produced meat in Nigeria, which possesses about 22.1 million sheep (FAO, 2023). However, the lack of genetic information has prevented farmers from optimizing the full potential of sheep breeds in Nigeria.

Decisions on applying marker-assisted selection (MAS) for genetic improvement of any breed must consider traits of economic value and the specific identification of genes associated with those traits (Li *et al.*, 2006). The myostatin (MSTN) gene, also known as the growth differentiation factor-8 gene, is expressed in skeletal muscle and inhibits muscle growth (Bellinge *et al.*, 2005). Located on chromosome 2 in sheep (Archibald *et al.*, 2010), loss of functional myostatin causes the "double muscled" phenotype in various species, including sheep (McPherron and Lee, 1997; Grobet *et al.*, 1998; Broad *et al.*, 2000). Mutations in the





myostatin gene are linked to the muscular hypertrophy allele in double-muscled breeds (Kambadur *et al.*, 1997), presenting an opportunity to enhance processing yields using gene knockout technology (Kocabas *et al.*, 2002). Mutations in the myostatin gene have been reported in sheep breeds such as Kemieniec, Pomeranian, Medras, and Mecheri, with heterozygotes showing higher body weight (Amiya *et al.*, 2017). Most studies on Nigerian sheep breeds are morphological (Agaviezor *et al.*, 2012; Asamoah and Sam, 2016), resulting in a scarcity of molecular markers and making genetic improvement programs challenging. Thus, examining the myostatin (MSTN) gene and its variants in breeds of sheep in Nigeria is crucial for identifying animals with desirable genotypes for future selection programs, particularly in MAS for economic traits. These genetic markers will be valuable for selection and breeding programs, as variations in the non-coding regions of the myostatin (MSTN) gene relate to muscle growth and meat quality traits in sheep, impacting the gene.

# MATERIALS AND METHODS

### The Study Area

This study focuses on, in-silico analysis of the myostatin (MSTN) gene in the breeds of sheep in Nigeria. The research utilizes several bioinformatics tools to understand the evolutionary relationships, genetic distances, sequence similarities, and potential effects of mutations in the myostatin (MSTN) gene sequences. All analysis were done with bioinformatics software programs namely; MEGA (molecular evolutionary genetics analysis tool); BLAST (Basic local alignment search tool); and SIFT (sorting intolerant from tolerant) which were installed in the computer and optimized.

#### Myostatin (MSTN) Sequences of Breeds of Sheep in Nigeria

Eight myostatin (MSTN) gene sequences were analyzed, with two sequences each from West African Dwarf (W.A.D), Uda, Balami, and Yankasa breeds. These sequences were retrieved from the NCBI GenBank (www.ncbi.nlm.nih.gov) with the following accession numbers; MZ065344.1, MZ065345.1, for WAD; MZ065339.1, MZ065340.1, for Uda; MZ065334.1, MZ065335.1, for Balami; and MZ712587.1, MZ712588.1, for Yankasa.

# **Sequence Alignment and Translation**

Sequence alignment, translation, and comparison were performed using ClustalW (Larkin *et al.*, 2007) from MEGA with the IUB substitution matrix, a gap open penalty of 15, and a gap extension penalty of 6.66.

# Identification of Mutations of Myostatin (MSTN) Gene Sequences Selected

To identify mutations of myostatin (MSTN) gene sequences, the Basic local alignment search tool (BLAST)x algorithm on the NCBI BLAST website (<u>www.ncbi.nlm.nih.gov</u>) was accessed. Myostatin gene sequence was pasted into the "Enter query sequence" field maintaining default parameters, then standard non-redundant protein sequence databases were selected, and the BLASTx algorithm was ran to compare the query sequence to the selected database. The pairwise with dots alignments was selected to identify mutations and similarities between the query sequence and matched sequences. One of the most common means to search sequence databases is through sequence similarity with known sequences. The mechanisms for the sequence similarity search tools available include Blast (Altschul *et al.*, 1990).

### Characterization of Variations of Myostatin (MSTN) Gene Sequences Selected

To characterize gene variants, we used the SIFT (Sorting Intolerant from Tolerant) tool (https://sift.bii.a-star.edu.sg). The protein sequence was entered into the SIFT input field, and the appropriate database and parameters were selected. SIFT predicted the effects of amino acid substitutions on protein function, using a threshold value of  $\leq 0.05$ . Substitutions scoring less than 0.05 were deemed deleterious, while those scoring higher were considered tolerant.





SIFT, which uses UniProt as protein reference database, is a widely used algorithm for predicting the functional effects of amino acid substitutions (Ng and Henikoff, 2001; Thomas *et al.*, 2003).

## **RESULTS AND DISCUSSION**

### **Results Retrieved Sequences and Base pairs**

The variation in sequence length of was not significant between the breeds of sheep, with all the breeds having the same base pair (511), except for Yankasa, which had 580bp per sequence (Table 1). All these sequence lengths partial coding sequences (partial CDS) because they had less than six thousand base pairs (<6000 bp) each. Variability might arise from DNA duplication, rearrangement, short tandem repeats (STR), insertions, or deletions (indels). Sequences MZ065344.1, MZ065345.1, MZ065339.1, MZ065340.1, MZ065334.1, and MZ065335.1 have 511 bp and come from exon 1, while MZ712587.1 and MZ712588.1 have 580 bp and are from the promoter region. Such variability can lead to unique structures and biological activities among individuals (Bhattacharya *et al.*, 2008).

### **Sequence Alignment**

The myostatin gene sequences were aligned without gaps, indicating high similarity and conservation among the sequences. This lack of gaps suggests minimal evolutionary insertions or deletions, allowing for seamless alignment (Durbin *et al.*, 1998; Mount, 2004). Proper alignment parameters, such as gap penalties, also contribute to minimizing gaps (Thompson *et al.*, 1994). For short sequences, fewer variations necessitate gaps, further leading to smooth alignments (Higgins and Sharp, 1988).

### **Genetic Distances**

The genetic distances revealed the relationship between the four breeds of sheep in Nigeria. It showed that Balami and Uda were closer with a distance of 0, which was attributed to the fact that Balami and Uda had a common ancestor. This result was similar to Yunusa on morphology of breeds of sheep in Nigeria who reported that Balami and Uda were the closest (Yunusa *et al.*, 2013). Yankasa and Balami had a maximum distance of 0.568693 even though they had a common ancestor. This result is similar to Abubakar on genetic diversity of breeds of sheep in Nigeria who reported that Yankassa and Balami had the farthest distance (Abubakar *et al.*, 2020) (Table 2). Nei (1987) expounded the concept by stating that genetic distance is "the extent of gene differences between populations or species that is measured by some numerical quantity." A second definition was given by Beaumont *et al.*, (1998). They defined





genetic distance as a "quantitative measure of genetic difference, be it at the sequence level or the allele frequency level that is calculated between individuals, populations or species."

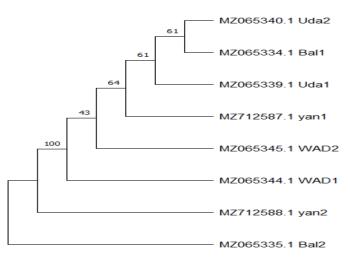

## Nei Genetic Distance: West African Dwarf (Wad), Balami (Bal), Yankasa (Yan) Evolutionary Relationships

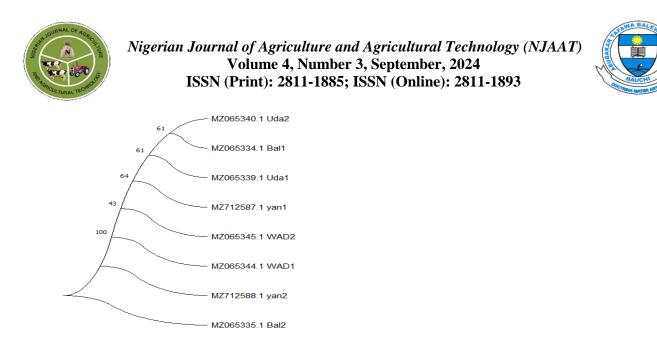


Figure 2: Phylogenic Relationships of the Sequences Considered using UPGMA Bootstrap Concession Tree

The UPGMA consensus tree in Figures 2 and 3 showed that the first node, which carried Balami and Uda, were closer to a common ancestor than the others. The last node, which carried Yankasa and Balami, also had a common ancestor. The evolutionary relationships in Figures 2 and 3 indicated that breeds coming from the same nodes had a common ancestor. The sequences considered for the myostatin (MSTN) gene showed that seven nodes stemmed from the root. Balami 1 and Uda 2, West African Dwarf 1 and West African Dwarf 1, Yankasa 1 and Uda 1, and Balami 2 and Yankasa 2 all had a common ancestor. However, the node of interest was the first node, which carried Balami and Uda, indicating they were more homologous to the ancestors of breeds of sheep in Nigeria, similar to the report by Yunusa *et al.*, (2013).

#### **Characterization of Mutations in the Sequences Considered**

There were twenty-one (21) amino acids substitutions of myostatin (MSTN) gene sequence considered. Eighteen (18) were tolerant, namely: Lysine 49 Threonine, Phenylalanine 13 Isoleucine, Phenylalanine 7 Tyrosine, Leucine 16 Isoleucine, Lysine 36 Glutamic, Leucine 43 Methionine, Asparagine 48 Threonine, Asparagine 49 Lysine, Leucine 51 Serine, Arginine 31 Glutamic, Proline 55 Alanine, Glycine 56 Isoleucine, Threonine 58 Isoleucine, Proline 59 Glutamic, Serine 60 Isoleucine, Lysine 36 Glutamic, Leucine 43 Methionine, and Arginine 57 Lysine were tolerant. Three (3) substitutions, namely; Glutamic 34 Glycine, Arginine 45 Glycine, Tyrosine 9 Cysteine, were deleterious (Table 3).

Sift score of < 0.05 is deleterious, while score of > 0.05 is tolerated.





The SIFT algorithm predicts the impact of amino acid substitutions on protein function based on the conservation of amino acids within a protein family. It assumes that well-conserved positions are crucial for protein function, thus substitutions at these positions are likely to be deleterious. For instance, substitutions from hydrophobic to hydrophilic amino acids or vice versa may be tolerated or deleterious depending on the protein's requirements. SIFT assigns a score to each substitution, with scores below 0.05 indicating a prediction of deleterious impact, though some suggest using a threshold of 0.1 for better sensitivity. This computational approach aids in identifying functional mutations in genetic studies, distinguishing beneficial mutations from those that reduce fitness, and is valuable in both human and animal genetics research (Tariq *et al.*, 2013).

# CONCLUSION AND RECOMMENDATIONS

It was concluded from the study that; the sequence length of the myostatin (MSTN) gene in breeds of sheep in Nigeria varies between 511 and 580bp and within these breeds of sheep in Nigeria, there were both beneficial and harmful mutations in the myostatin (MSTN) gene. The beneficial mutations were more prevalent than the harmful ones. The study recommended selective breeding strategies to propagate the beneficial mutations identified, enhancing muscle growth and meat yield in breeds of sheep in Nigeria.
